Venue

- ✓ Considering the location's accessibility, proximity to accommodations with sustainability measures and **environmental certifications (such as EMAS or ISO 14001)**
- ✓ Evaluating the venue's **energy sustainability**, use of **renewable energy** and **energy efficiency**
- ✓ Opting for an **outdoor venue**, if feasible and suitable for the event, in order to reduce costs, **minimise the environmental impact** and embrace the natural surroundings



Food and Beverage

Reducing the amount of **single-use plastic containers** and opting for reusable dishes and glasses or, if single-plastics cannot be avoided, opting for **biodegradable** or **compostable** variants

Planning for food consumption according to the number of attendees to lower food waste

Offering **fully vegan food** options, reducing meat dishes and choosing zero-km local products

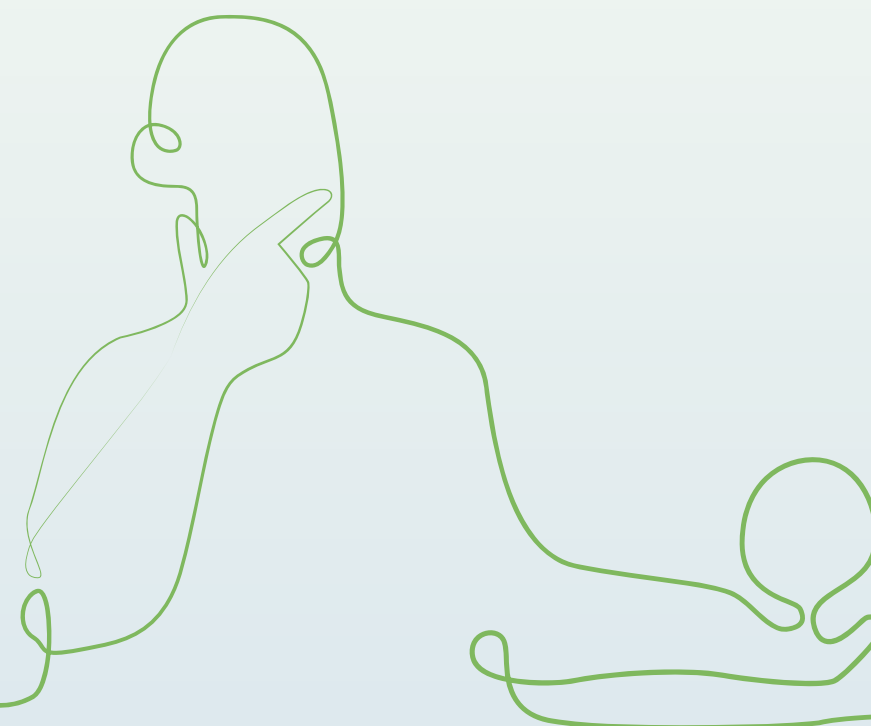
If providing coffee or tea, ensuring that they are sourced sustainably, with **certifications** such as Rainforest Alliance Certified Coffees, Bird Safe Coffee, and **Fair-Trade Certified Teas**

Promotional actions and gifts

- ✓ Minimising the distribution of unnecessary printed materials by printing leaflets in lower quantities and using recycled or certified paper
- ✓ Opting for digital marketing alternatives
- ✓ Ordering gifts based on your participant list in order to reduce waste and avoid excess



Materials

- ✓ Repurposing and adapting existing materials to different events to reduce waste
- ✓ Opting for a minimalist setting by reducing material consumption and creating a clean aesthetic
- ✓ Maintaining an up-to-date inventory of all available materials, props and costumes to effectively manage resources
- ✓ Prioritising eco-friendly and sustainable detergents and cosmetics with EU Ecolabel certification
- ✓ Collaborating with local networks, venues and communities to share rigs, props and resources
- ✓ Sourcing materials and props in thrift and second-hand stores
- ✓ When new props are needed, prioritising materials such as wood and cloth over plastics

Guidelines for attendees

- ✓ Encouraging attendees to reach the event venue using **sustainable transportation**, such as biking or public transport
- ✓ If attendees require accommodation, suggesting a selection of **green-certified hotels** close to the venue or easily accessible via public transport and a list of recommended restaurants which adopt sustainable practices
- ✓ Opting for digital tickets to minimise paper waste and streamline attendance tracking
- ✓ Ensuring recycling bins are clearly labelled and explaining recycling instructions to facilitate proper waste disposal
- ✓ Asking attendees for post-event feedback on sustainable practices adopted during the event
